Summit County Sheriff's Office

Kandy Fatheree assumed the office of Sheriff in January 2021 and is now serving her second term. As the Sheriff of Ohio's fourth largest county, she has more than 500 deputies, special deputies, and civilian staff under her command.

Fatheree grew up in Springfield Township and recalls wanting to work in law enforcement since the age of six. As a struggling single mother in her 30s, she sold nearly everything she owned to pay her way through the Police Academy. She started her career with the Lakemore Police Department in 1993, then joined the Summit County Sheriff's Office two years later.

Over the course of her three decades with the Sheriff's Office, she worked in nearly every unit and division and learned the office inside and out. She rose through the ranks to reach the level of captain, where she was tasked with overseeing the office's \$45 million budget.

In 2008, Fatheree attended the FBI National Academy for Executive Leadership, and it was then that she realized her dream of becoming Sheriff. She was proudly elected by the residents of Summit County in 2020, becoming the first woman to hold the office of sheriff in county history, and only the fourth in Ohio's history.

Among her top priorities, Fatheree is focused on boosting professionalism, performance, and efficiency within the agency, increasing diversity, outreach, and communication, and confronting the mental health and addiction crises in our community.

Sheriff Fatheree serves on the Board of Directors of the National Sheriff's Association, and she and her administration have been nationally recognized for their innovative and groundbreaking approaches.



The Operations Division
encompasses all patrol, investigative,
civil, and dispatch functions of the
Summit County Sheriff's Office. The
Division also includes our Training
Bureau, our many Specialty Units,
and our Community Policing
programs. In 2024, the Operations
Division was headed by Division
Commander, Chief Scott Cottle.

PATROL BUREAU

The Sheriff's Office Patrol Bureau patrols the entire county and is the policing agency for the City of Green, Coventry Township, Northfield Center Township, and Twinsburg Township, as well as providing security for the Akron-Canton Airport. Captain Dave McCutcheon, L.t Mike Lowe, and Lt. James Rimedio oversaw the Patrol Bureau in 2024.

The Crash Investigation Unit is a group of highly trained deputies responsible for investigating fatal and serious-injury crashes involving motorcycles, pedestrians, and commercial vehicles using accident reconstruction, vehicle dynamics, diagramming, and other skills. The Unit is also a part of the Summit Metro Crash Response Team, and in 2024 was under the direction of Lieutenant Mike Lowe.

CRIME SCENE INVESTIGATION

CRISIS NEGOTIATORS

The Crisis Negotiation Team is dispatched to resolve incidents involving barricaded subjects, hostage takers, or persons threatening suicide. Members accompany the SWAT Team on all high-risk operations. Negotiators partake in yearly training, including addressing those with mental illnesses or in altered mental states. Sergeant Chris Rhoades leads the Crisis Negotiation Team.

MOUNTED UNIT

DRONE RESPONSE TEAM

The Drone Response Team was created in 2024. The unit consists of deputies who are FAA certified to fly drones to be used in incidents like missing people, barricaded subjects, fleeing suspects, and more. The unit responded to 31 call outs in 2024. It is under the command of Captain Michelle Wiltrout.



DIVE RESCUE & RECOVERY

The Dive Rescue and Recovery Team consists of deputies who are certified divers and is attached to the South Summit Water Branch of the Summit County Special Operations Response Team (SORT). The team performed 252 hours of training in 2024, and responded to 2 call outs.



HONOR GUARD

The Honor Guard consists of six Deputies under the command of Sergeant Timakya Lewis. They serve as Guardians of the Colors at special ceremonies and events, and to honor their fallen comrades. In 2024 they performed their duties at eight events.



MOBILE FIELD FORCE

The Mobile Field Force was formed to respond to planned and unplanned events such as riots, protests, mass casualty disasters, and any other large-scale events where a team of deputies is needed. It is under the Command of Inspector Bill Holland.



DETECTIVE BUREAU

The Detective Bureau works on felony assignments and includes the Sex Offender Unit, Welfare Fraud Unit, Computer Crimes Unit, and members that work with the Summit County Human Trafficking Task Force. The Bureau also partners with Adult Protective Services, the Summit County Developmental Disabilities Board, and Summit County Children Services to conduct investigations within their purview. In 2024, the Bureau was led by Captain Karla Bloomingdale.



The Sheriff's Office is also responsible for property and evidence found, recovered, seized, or abandoned, and ensuring that all documents are completed for chain-of-custody purposes. In 2024, we received 3,638 pieces of property and returned or disposed of 1,102 pieces.

SEX OFFENDER UNIT

The Sex Offender Unit is tasked with maintaining the registry and compliance of over 1,100 sex offenders in Summit County. In addition to this, they also maintain a registry of arson and violent offenders. In 2024, Becky McCutcheon oversaw the Sex Offender Registry and it's 6 full time employees. A detective is assigned to conduct residency verifications throughout the county.

Megan's Law Classifications

- Sexually Oriented Offenders
 Required to register annual for 10 years.
- Habitual Sex Offenders
 Required to register annually for 20 years.
- Sexual Predators/Child Victim Predators
 Required to register every 90 days for life.

Adam Walsh Act Classifications

- **Tier 1:** Offenders must register annually for 15 years.
- **Tier 2:** Offenders must register every 6 months for 25 years.
- **Tier 3:** Offenders must register every 3 months for life.

Sex offenders are required to register according to the schedule established by which classification they fall into, and any time they change their address. Community notification cards are sent to all households within 1,000 feet when a Tier 3 or Sexual Predator changes their address. Additionally, residents can sign up on the Summit County Sheriff's website for email notifications of sex offenders moving into their neighborhood, or view an interactive map of nearby offenders on the Summit County Sheriff's Office mobile app.

DRUG UNIT

The Summit County Drug Unit is a collaborative effort headed up by the Sheriff's Office. It is comprised of our office, as well as Akron PD, University of Akron PD, New Franklin PD, Copley PD, Silver Lake PD, Cuyahoga Falls PD, Stow PD, the Ohio Dept. of Parole, the Ohio National Guard, the DEA, the ATF. The Drug Unit is overseen by Captain Michelle Wiltrout.

SUMMIT STARK NARCOTICS INTERDICTION TEAM

In 2024, the Summit and Stark County Sheriff's Offices and Copley Township Police Department formed the collaborative Summit Stark Narcotics Interdiction Team (SSNIT). In partnership with the Ohio Organized Crime Investigations Commission and Department of Homeland Security, the task force will focus on bulk narcotics and currency interdiction at hotels, airports, and bus terminals within the two counties.

During the time they operated in 2024, the SSNIT task force initiated 3 new cases and seized \$409,403.

INTERNAL AFFAIRS

The Internal Affairs Bureau is responsible for investigating citizen complaints, internal investigations, employee background investigations, drug testing, and any other special investigation. It is led by Lieutenant Ryan Gleespen and Sergeant Cathy Diesch.

CIVIL DIVISION

The Civil Division consists of deputies and civilian clerks who handle and serve the legal matters and paperwork issued by the courts. These include processing warrants, foreclosure and eviction notices, and conducting the auction of properties for mortgage foreclosures and delinquent taxes. COMMUNITY POLICING

The Community Policing Unit consists of numerous programs and events for county residents of all ages that are designed to both serve and bring together the community with the Sheriff's Office in order to form a better understanding and a stronger, mutually beneficial bond. Sergeant Pete Nervo oversees our Community Policing operations.

Carnival With a Cop – Local children are partnered with a deputy or officer who spends the day with them riding rides, playing games, visiting exhibitions, and eating all that great fair food. Lunch was provided for all, and bookbags and school supplies were handed out at the end of the event.

Christmas With a Cop – The Sheriff's Office partners annually with other local law enforcement agencies to host Christmas With a Cop, in which economically disadvantaged children are partnered with officers and deputies to do some Christmas shopping for their families and themselves.

Juvenile Diversion – A partnership between the Sheriff's Office, the Juvenile Court System, and local communities to help reduce juvenile crime by offering first-time, non-violent offenders the opportunity to perform community service.

Knox Box Program – Part of our *Senior Services*, the Knox Box program promotes senior safe living by allowing quick access to our seniors that are in need of prompt medical attention. Durable and secure lock containing house keys are hung outside the participant's home which only first responders can gain access to in the event of an emergency.

Neighborhood Watch – The Sheriff's Office is active in the Neighborhood Watch program, which is a special partnership between deputies and residents who share a common goal of identifying crime problems and working together on solutions in the areas where they patrol or live.

Quick Response Team – A team comprised of a counselor, a paramedic, and a member of law enforcement that visits individuals who have suffered a drug overdose, with the goal of convincing them to seek treatment and establish a path to recovery. While on scene, the team provides resources for overdose victims and their families.

S.M.A.R.T. Trailer – The Speed Monitoring Awareness Radar Trailer (S.M.A.R.T.) is used by the Sheriff's Office to address speed complaints, educate the public on problem areas, and gather data related to speeding and traffic volume to develop remedies.







Safety City – A five-day program designed to educate prekindergarten children residing in or attending school in one of our patrol districts. The program covers a variety of topics such as: stranger danger, bicycle safety, water safety, seat belts, crossing the street, traffic lights, fire safety, 911, and more.

School Resource Officers – The Sheriff's Office has deputies assigned to several school districts in the county that provide security at their assigned schools, engage in conflict resolution with the students, and educate parents and students on safety and security matters. We also perform safety assessments at the request of school districts, offering security recommendations, and developing lockdown and rapid response plans.

Senior Coalition – Sheriff's Office volunteers and different community entities and organizations arrange programs and presentations throughout the year that cover topics relevant to seniors.

Senior Watch – Designed to serve and protect senior citizens who live alone, those enrolled in the program are paired with a deputy who will check in regularly with them to ensure their safety and well-being.

Summit Safe Communities – Funded by a grant to the Sheriff's Office from the Ohio Department of Public Safety, Summit Safe Communities focuses on driving safety issues such as seatbelt use, distracted driving, impaired driving, and more.

Take Me Home – A partnership between the Sheriff's Office and Prosecutor's Office designed to support those with disabilities who may need extra help communicating in an emergency situation. This program allows for the rapid identification and safe return of citizens who are unable to adequately communicate vital information such as their name and address to law enforcement.

Toys for Tough Times – Our Community Policing Unit partners with local churches, organizations, and individuals to provide stuffed animals, blankets, and other toys to our patrol deputies to give to children in difficult situations or who have just experienced a trauma or loss.







D.A.R.E.

Summit County Sheriff's Deputies have taught Drug Awareness Resistance Education (D.A.R.E.) across the county for over three decades. It is offered to over 6,000 children in five school districts and nine parochial schools each year. Currently, the Sheriff's Office provides five programs from Pre-K through Eighth Grade.

Inmate meals are provided through a contract with *Aramark*, with menus approved by a dietician to meet nutritional standards. In 2024, there were a total of 634,737 meals served. Additional options to purchase food and snacks are available through *Fresh Favorites* and *I-Care*.

MEDICAL SERVICES

The Medical Unit is a contracted service with VitalCore Health Strategies and consists of a physician medical director, nurse practitioner, dentist, dental assistant, administrative assistant, and a team of 6 registered nurses and 16 licensed practical nurses. It is overseen by Director of Nursing and the Health Services Administrator, Kimberly Ward.

Medical care is provided 24/7, ranging from emergency response, medical screening and admission, chronic medical care maintenance, lab, and diagnostic testing, IV therapy, medication assisted drug treatment, detoxification and withdrawal, and more.
